## FIELDPRINT FINGERPRINTING PROGRAM FOR VECHS QUALIFIED PROVIDERS

The Fieldprint Fingerprinting Program for Volunteer and Employee Criminal History System (VECHS) Qualified Providers offers a large network of convenient, friendly and state-of-the-art Livescan fingerprint collection sites throughout Florida to help you comply with the National Child Protection Act (NCPA) (1993), as amended, and Florida Statute 943.0542 (1999). Fieldprint is an FDLE-authorized Livescan vendor.

### Highlights of our Livescan Fingerprint Collection in Florida include:

- Large Livescan network providing locations within 25 miles of 98 percent of Florida’s population.
- Sites that are professional, highly accessible and employ state-of-the art technology. Our sites are located in easy-to-find retail locations, not government offices.
- Web-based site location and scheduling system.
- Web-based system to track the status of each fingerprint submission.

Whether you need to fingerprint one applicant or 100,000, Fieldprint combines the latest technology and the most comprehensive service to create a positive, professional experience for your applicants.

There are four options for participating in the Fieldprint Fingerprinting Program for VECHS Qualified Providers. These options can be mixed and matched to address your unique needs.

### OPTION 1: Fingerprint Livescan Collection Site Network

We match each applicant with the closest fingerprint collection site both in the state of Florida and nationwide. Our database contains information about each site, including its location, hours of operation and any special site-specific procedures. This information is integrated into the web-based scheduling process to ensure that the applicant has the most positive and efficient fingerprinting experience possible.

*Pricing — \$16.00 per person*

*Pricing does not include VECHS fingerprint submission fee of \$38.75 per employee, \$30.50 per volunteer.*

### OPTION 2: Client-Based Fingerprint Collection

In cases where a client may fingerprint a large number of applicants in one location (such as a headquarters office), it can choose to have Livescan fingerprinting equipment placed on-site in its office. Fieldprint handles the installation, maintenance and training associated with the Livescan equipment, acceptance of electronic fingerprint files and file submission. The client is only responsible for the cost of fingerprinting on a usage basis. This option eliminates the expense and resources typically involved in purchasing and maintaining Livescan equipment.

*Pricing — Varies by Volume and Location.*

### OPTION 3: Mobile On-Site Fingerprint Collection

Our mobile Livescan fingerprinting option is available if you have 40 or more applicants at a single location that need to be fingerprinted at one time. A trained fingerprint technician equipped with a portable Livescan system is dispatched to a location of the client’s choice to collect applicants’ fingerprints.

*Pricing — Varies by Volume, Location and Scheduling*

### OPTION 4: Fingerprint Paper Card Scanning

If you have out-of-state applicants that do not have access to our national network of Livescan sites, you can use a paper fingerprint card supplied by Fieldprint and have the applicant’s fingerprints taken remotely. Fieldprint can then process the cards and submit prints electronically to FDLE for VECHS purposes.

*Pricing — \$16.00 per card scanned and submitted to VECHS.*
